



ORDER

NO.SO(Jud-1)/8-1(04)/2020 (Stage-3 NPIs): In continuation and partial modification of this department's order of even number dated 31.03.2021 & 12.04.2021 and in pursuance of the decisions at NCOC special session dated 13.04.2021 communicated vide letters No.801/A/ NCOC-01 dated 13.04.2021, the Government of Sindh in exercise of the powers under Section 3 (1) of Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015) is pleased to re-direct as under with immediate effect and till 16th May, 2021, unless changed or amended earlier:-

- a) **Broader lockdowns (BLDs)** in areas with more than 8% positivity with stringent enforcement protocols based on risk assessment and no mobility except emergency on disease hotspots by respective Commissioners and Deputy Commissioners under Sindh Epidemic Diseases Act 2014.
 - b) **All commercial / business / Markets timings from Sehr till 06:00 PM** less essential services with two closed days observance (**SATURDAY & SUNDAY**) (essential services as clarified in this department's letter of even number dated 08.04.2021).
 - c) All Kind of gatherings and (indoor as well as outdoor) including social, cultural, political, sports, musical and miscellaneous events are completely banned.
 - d) **Restaurants – No indoor dining.** Outdoor dining from **Iftar till Mid-Night i.e 11:59 PM** with strict COVID SOPs and thereafter only takeaway / home delivery.
 - e) **Taraveeh prayers** to be organized in Open spaces as far as possible, civil administration at every tier to engage Ulemas and community leaders for assistance in enforcement of COVID SOPs during Ramadan Ul Mubarik
 - f) **Complete closure of Cinemas and Shrines**
 - g) **Complete ban on contact sports, festivals, cultural and other events**
 - h) **Complete closure of Amusement Parks.** However, walking, jogging tracks will remain open with strict adherence of COVID SOPs.
 - i) **Complete Ban on marriage functions indoor and outdoor.**
 - j) **Work from Home** - 50% of the staff in all public / private sector offices.
 - k) Intercity Public Transport to operate at 50% of Capacity with strict SOPs compliance.
 - l) **Ban on Inter-Provincial Pubic Transport** on two closed days (**Saturday & Sunday**) till midnight 25/26 April, 2021.
 - m) **Compulsory Mask wearing and Social Distance** - at all Government / private offices and Public places.
2. Disease spread will be reviewed further on 06th May 2021 at NCOC forum for any further required actions.
3. The SOPs issued vide Home Department, Government of Sindh Order NO.SO(Jud-1)/HD/8-1(04)/2020-Corona/SOPs dated 06.11.2020 strictly to be complied.


